RELEASE / WAIVER / COVENANT NOT TO SUE - READ CAREFULLY

I understand that there are inherent risks and dangers involved in the sport of in-line skating. I hereby voluntarily and knowingly agree to assume all risks of any personal injury, property damage or loss, which may result from my participation in The Great EsSkate ("The Event"). In consideration of acceptance for participation in "The Event", I (the undersigned, intending to be legally bound for myself, my heirs, executors, administrator and assigns) hereby, Covenant Not To Sue, Release, Forever Discharge, and Hold Harmless of any officer, director, trustee, organizer, coordinator, sponsor, and/or any member of South Beach NSP, Inc. or National Skate Patrol, Inc (NSP), for and from any and all liability, claims, causes of actions, suits and/or demands, whether known or unknown, for any personal injury, property damage, loss accident or occurrence, resulting from my participation in "The Event", or resulting from negligence of any kind on the part of any NSP, whether acting in their official capacity or not (collectively, the "Claims"). I hereby agree to Waive any such claims against National Skate Patrol. I also understand that I may be filmed or taped as part of "The Event" and that my image, likeness, and voice may be broadcast, displayed, shown, projected, reproduced, or otherwise used by third parties. I authorize this filming, taping, and other use and understand that I have no right or interest in the resulting footage or in any program or other display utilizing such footage of me made during "The Event" in any media whatsoever.

I further acknowledge that the use of Helmets and Blinkie Lights are required during "The Event". Wrist guards, elbow pads, & reflective clothing are recommended. South Beach NSP, Inc. recommends that all participants in "The Event" carry medical and liability insurance and wear full protective gear (i.e. helmet, wrist guards, kneepads, elbow pads, and reflective clothing and blinking lights for night skating).

I also acknowledge that there are particular inherent risks of injury or even death when involved in city in-line skating during "The Event", including but not limited to: dangers arising from falls, equipment failure, collision with vehicles, bicycles, other skaters, pedestrians, animals, unexpected obstacles including potholes, manhole covers, gates, chains, trolley tracks, cobblestones, bad pavement, water, oil, debris, gravel, curbs, stairs, hills and inclines. I acknowledge that conditions on the street, including the weather and lighting, are constantly changing. Finally, I verify that I must be in good health to participate in "The Event", my equipment must be in good condition, and that I possess and have mastered the minimum required skate skills to participate in "The Event" (i.e. the ability to skate in control, especially on hills and in groups of skaters; to stop in traffic; to maneuver curbs; and to avoid obstacles). I have read this Release / Waiver / Covenant Not To Sue and I accept the terms hereof.
